**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR IMELDA CALIXTO-RUBIANO, FOR AND ON BEHALF OF THE CITY OF PASAY, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL AUTHORITY FOR CHILD CARE (NACC) FOR THE IMPLEMENTATION AND SUSTAINABILITY OF THE PHILIPPINE FOSTER CARE PROGRAM (PFCP) AS SUBSTITUTE TO PARENTAL CARE FOR CHILDREN IN NEED OF SPECIAL PROTECTION, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS**

**WHEREAS**, the National Authority for Child Care (NACC) is mandated to provide alternative parental care, protection and assistance to every child who is surrendered, orphaned, abandoned, neglected or dependent through adoption and/or foster care;

**WHEREAS**, the National Authority for Child Care (NACC) recognizes the role of the Local Government Units (LGUs)/Non-governmental Organizations (NGOs) in responding to the needs of Children in Need of Special Protection (CNSP) of the City Government of Pasay identified as one of the partners in project implementation;

**WHEREAS**, the National Authority for Child Care (NACC) rebranded the *Aruga at Kalinga Para sa mga Bata sa Barangay* (AKBB) strategy into Philippine Foster Care Program (PFCP) to align its policies and procedures based on the capacity and resources of the LGUs. It aims to promote the Foster Care Program as the best substitute parental care for children in need of special protection and increase the pool of licenses foster parents in every locality through partnership with the LGUs;

**WHEREAS**, the National Authority for Child Care (NACC), through its Regional Alternative Child Care Office (RACCO), provides capacity-building activities, other activities, and necessary support related to project implementation;

**WHEREAS**, the City Government of Pasay is mandated to promote the foster care system in its local jurisdiction. As such, it agrees to support the Philippine Foster Care Program of the NACC to ensure the optimum growth, rehabilitation, and development of children placed under foster care. Moreover, the City signifies its full support for the implementation and sustainability of the project;

**WHEREAS**, Ms. Mary Cris L. Balictar, RSW, Department Head of the Pasay City Social Welfare and Development Department (PSWDD), in a letter dated November 5, 2024, forwarded the draft of the Memorandum of Agreement to the Office of the City Legal and requested it to be endorsed to the Sangguniang Panlungsod for the issuance of a Resolution authorizing the City Mayor to sign the same;

**WHEREAS**, on November 7, 2024, the Honorable City Mayor Imelda Calixto-Rubiano officially endorsed to the members of the Sangguniang Panlungsod a copy of the said Agreement for the adoption of an appropriate legislation;






