A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR IMELDA CALIXTO-RUBIANO TO ENTER INTO AND SIGN, FOR AND ON BEHALF OF PASAY CITY GOVERNMENT, THE MEMORANDUM OF UNDERSTANDING WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE – NATIONAL CAPITAL REGION (DSWD FO – NCR) FOR THE IMPLEMENTATION OF THE PROJECT RESOLVE (RESPONSE ENGINE FOR SYSTEMATIC OPERATIONALIZATION OF LOGISTICS AND VOLUNTEERS IN EMERGENCIES), SUBJECT TO ALL EXISTING LAWS, RULES, AND REGULATIONS

WHEREAS, Republic Act No. 11032 states that all government offices and agencies including LGUs, GOCCs, and other government instrumentalities whether located in the Philippines or abroad should provide services covering business and non-business related transactions and shall take appropriate measures to promote transparency in each agency with regard to the manner of transacting with the public for the adoption of simplified requirements and procedures that will reduce red tape and expedite business and non-business transactions in the government;

WHEREAS, Republic Act No. 10121 or the Philippine Disaster Risk Reduction and Management mandates the LGUs to be the first responders to disaster response and the DSWD in the resource augmentation;

WHEREAS, in the continuous effort to systematize and streamline the resource augmentation, the DSWD FO-NCR develops the Project RESOLVE for a unified coordination with the Parties;

WHEREAS, the Project RESOLVE (Response Engine for Systematic Operationalization of Logistics and Volunteers in Emergencies) is a website designed with user-friendly features for easy navigation. Currently, the website offers features to promote the public’s participation in the efficient and effective disaster management;

WHEREAS, the Regional Memorandum Circular (RMC) No. 1, Series of 2024 provides the regulation of the implementation of Project RESOLVE which will be implemented in the NCR;

WHEREAS, pursuant thereto, the Parties agree to enter into a strategic alliance by way of a partnership in promoting their services as government entities assigned as the first and second responders in terms of disasters, calamities, and or emergencies that may be encountered in the future;

WHEREAS, the respective cooperation and involvement of the City Government of Pasay will be needed for the facilitation and marketing purposes of the innovation website by the DSWD FO-NCR called “Project RESOLVE”, to be launched to the general public in the City of Pasay;

WHEREAS, to foster familiarization and expectations in the procedures of the launching, both DSWD FO-NCR and the City Government of Pasay agree to exchange ideas and concepts to gain a successful outcome;

WHEREAS, Ms. Mary Cris L. Balictar, RSW, Department Head of the Pasay City Social Welfare and Development Department (PSWDD), in a letter dated November 5, 2024, forwarded the draft of the
