**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR IMELDA CALIXTO-RUBIANO, FOR AND ON BEHALF OF THE CITY OF PASAY, TO ENTER INTO AND SIGN THE RELIEF PREPOSITIONING AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR PROVIDING TECHNICAL AND RELIEF AUGMENTATION ASSISTANCE TO LGU'S AFFECTED BY DISASTER, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS**

**WHEREAS**, the Department of Social Welfare and Development (DSWD) through its Field Offices is mandated to provide technical and relief augmentation assistance to LGU's affected by disaster beyond its capabilities;

**WHEREAS**, the Local Government Units (LGUs) under Republic Act 7160 shall provide relief services and assistance for the victims during and in the aftermath of disaster and their return to productive livelihood following the said incident;

**WHEREAS**, the City Government of Pasay thru the Pasay City Social Welfare and Development Department (PSWDD), with its available designated relief warehousing facility at Social Development Center SDC, #84 Sun Valley Drive NAIA Road, Pasay City, is willing to accommodate the prepositioned relief goods of the DSWD-NCR to be used exclusively during disasters;

**WHEREAS**, Ms. Mary Cris L. Balictar, RSW, Department Head of the Pasay City Social Welfare and Development Department (PSWDD), in a letter dated November 6, 2024, forwarded the draft of the Relief Prepositioning Agreement to the Office of the City Legal and requested it to be endorsed to the Sangguniang Panlungsod for the issuance of a Resolution authorizing the City Mayor to sign the same;

**WHEREAS**, on November 7, 2024, the Honorable City Mayor Imelda Calixto-Rubiano officially endorsed to the members of the Sangguniang Panlungsod a copy of the said Agreement for the adoption of an appropriate legislation;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod, in session duly assembled, **AUTHORIZING THE HONORABLE CITY MAYOR IMELDA CALIXTO-RUBIANO, FOR AND ON BEHALF OF THE CITY OF PASAY, TO ENTER INTO AND SIGN THE RELIEF PREPOSITIONING AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR PROVIDING TECHNICAL AND RELIEF AUGMENTATION ASSISTANCE TO LGU'S AFFECTED BY DISASTER, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.**
