**A RESOLUTION APPROVING AND ADOPTING THE PASAY CITY HEALTH BOARD RESOLUTION NO. 06-F, SERIES OF 2024 RECONSTITUTING (EXPANDING) THE MEMBERS OF THE CITY LOCAL HEALTH BOARD, THE CREATION AND STRENGTHENING OF ITS SUPPORT UNITS, CITY HEALTH OFFICE AND ITS DIVISIONS, DEFINING ITS DUTIES AND FUNCTIONS FOR THE IMPLEMENTATION OF THE UNIVERSAL HEALTH CARE ACT IN PASAY CITY APPROVED ON JUNE 21, 2024, SUBJECT TO ALL APPLICABLE LAWS, RULES AND REGULATIONS ON THE MATTER**

**WHEREAS**, Article XVIII, Section 11 of the 1987 Constitution states that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost, with priority for the needs of the underprivileged, sick, elderly, disabled, women, and children;

**WHEREAS**, Section 102 of the Republic Act No. 7160 or the Local Government Code of 1991 states that a Local Health Board should be established in every province, city or municipality following the composition and performing the functions provided by law;

**WHEREAS**, the same section further states that the Local Health Board shall be the main advisory and policy board of the LGU for health system management in terms of budget administration, public health management, and implementation of technical and administrative standards, and likewise shall design and implement its own organizational structure and staffing pattern for local health system development;

**WHEREAS**, Section 19 of RA 11223 or the Universal Health Care (UHC) Act states that the City Health Board shall oversee and coordinate the integration of health services for the City-Wide Health System (CWHS) in highly urbanized and independent component cities;

**WHEREAS**, the UHC Act mandates the City Health Board, in the case of City-Wide Health Systems, to manage the Special Health Fund referred to Section 20 of this Act and shall exercise administrative and technical supervision over health facilities and health human resources within their respective territorial jurisdiction;

**WHEREAS**, Department of Health Administrative Order No. 2020-0021, dated 22 May 2020, sets the guidelines on the integration of the CWHS, specifying for its purpose the minimum composition and functions of the City Health Board and the Management Support Unit consistent with the UHC Act, expounded further by DOH-DBM-DOF-DILG-PHILHEALTH Joint Memorandum Circular 2021-0001, dated 13 January 2021, regarding the guidelines on the allocation, utilization, and monitoring of, and accountability for, the Special Health Fund;

**WHEREAS**, Section 19.15 and 19.18 of the Implementing Rules and Regulations (IRR) of the UHC Act provided for the creation of at least two (2) divisions under the City Health Office and the Management Support Unit (MSU) to assist the City Health Board on its operations including the management of the Special Health Fund respectively;

**WHEREAS**, the City Government of Pasay has an existing functional Local Health Board following the mandate of RA 7160 and acknowledges the need to reconstitute (expand) the City Local Health Board, create its Management Support Unit and reorganize the City Health Office in compliance

with the mandates of the Universal Health Care Act, its Implementing Rules and Regulations and other related national issuances and guidelines;

**WHEREAS**, Resolution No. 6579, Series of 2023 supports the intent of the Local Government of Pasay to be a part of the integration site on the implementation of the Universal Health Care.

**WHEREAS**, on May 27, 2024, Hon. Mayor Imelda G. Calixto-Rubiano entered into a Memorandum of Understanding with the Department of Health (DOH) and Philippine Health Insurance (Philhealth) for the implementation of Universal Health Care Act in the City of Pasay as one of the integration sites in Metro Manila;

**WHEREAS**, pursuant to the Republic Act (RA) No. 7160 or the Local Government Code of 1991, through the Executive Order (EO) No. 138 Series of 2021 or the "Full Devolution of Certain Functions of the Executive Branch to Local Governments, Creation of a Committee on Devolution, and for Other Purposes" dated June 1, 2021 and its IRR dated July 2, 2021, the Department of Health (DOH) developed the Devolution Transition Plan (DTP) Annex C – 2 thereof presents the "Minimum Recommendations for Staffing Complement of Public Health Facilities and Health Offices in Local Government Units.


**WHEREAS**, pursuant thereto, the Pasay City Local Health Board adopted Resolution No. 06-F, Series of 2024 approved on June 21, 2024 *"Reconstituting (Expanding) the Members of the City Local Health Board, the Creation and Strengthening of its Support Units, City Health Office and its Divisions, Defining its Duties and Functions for the Implementation of the Universal Health Care Act in Pasay City"*;


**WHEREAS**, on December 04, 2024, the Honorable City Mayor Imelda Calixto-Rubiano endorsed to the Sangguniang Panlungsod a copy of the above mentioned resolution for approval and adoption of the Sangguniang Panlungsod;
