WHEREAS, the City Government of Pasay shall endeavor to ensure the progressive establishment of local committees, offices, units, and individuals charged with supervising the implementation of health promotion policies, program, and activities in the city in accordance with the Health Promotion Framework Strategy (HPFS) 2021-2030;

WHEREAS, the City Government of Pasay should incorporate the resource requirements for the sustainable implementation of local health promotion laws, policies, programs, and activities based on the HPFS 2021-2030 into the city investment plan for health and yearly operating plan;

WHEREAS, one of the principles embodied to be carried out by the implementing rules and regulations of Republic Act No. 11223 also known as the Universal Health Care Act is an integrated and comprehensive approach ensuring that all Filipinos are health literate, provided with healthy living conditions, and protected from any hazards or risks that could have a negative impact on their health;

WHEREAS, the HPFS 2021-2030 requires whole-system, whole-government, and whole-society action through partnership and collaborations with government instrumentalities, non-government, civil society or community-based groups and organizations, local academic institutions, the private sector, and other entities whose goals and objectives align with the public health sector's strategic directions and standards;

WHEREAS, Section 30.11 of the Universal Health Care Act's Implementing Rules mandates that local government units, guided by the health promotion framework strategy, shall issue and implement effective health promotion policies and programs that promote health literacy and a healthy lifestyle among its constituents, prevent and control diseases and their risk factors, and advance population health and individual well-being;

WHEREAS, Section 19.9 of the above-mentioned Implementing Rules also mandates that local government units, as part of their commitment to providing city-wide integration shall ensure the managerial and financial integration and provide the necessary resources and support mechanisms to make the integration possible and sustainable;

WHEREAS, pursuant to the Universal Health Care Act, the Department of Health (DOH) has formulated Administrative Order No. 2021-0063 or the Health Promotion Framework Strategy (HPFS) 2021-2030 to serve as the overall national health promotion roadmap and foundation for all health promotion policies, programs, and activities at the national, regional and local levels;

WHEREAS, the HPFS 2021-2030 mandates that the development and implementation of health promotion policies, programs, and activities concentrate on diet and physical activity, environmental health,

WHEREAS, on December 04, 2024, the Honorable City Mayor Imelda Calixto-Rubiano endorsed to the Sangguniang Panlungsod a copy of the above mentioned resolution for approval and adoption of the Sangguniang Panlungsod;
