**A RESOLUTION APPROVING AND ADOPTING THE PASAY CITY HEALTH BOARD RESOLUTION NO. 06-G, SERIES OF 2024 ADOPTING R.A. 10152 KNOWN AS THE IMPLEMENTATION OF BASIC IMMUNIZATION SERVICES FOR INFANTS AND CHILDREN APPROVED ON JUNE 21, 2024, SUBJECT TO ALL APPLICABLE LAWS, RULES AND REGULATIONS ON THE MATTER**

**WHEREAS**, Republic Act No. 10152 otherwise known as “Mandatory Infants and Children Immunization Act of 2011”, declares the policy of the State to take a proactive role in the preventive health care of infants and children. Towards this end, the State shall adopt a comprehensive, mandatory and sustainable immunization program for vaccine-preventable disease for all infants and children. This covers the following vaccine-preventable diseases:

- (a) Tuberculosis;
- (b) Diphtheria, Tetanus and Pertussis (DPT);
- (c) Poliomyelitis;
- (d) Measles;
- (e) Mumps;
- (f) Rubella or German Measles;
- (g) Hepatitis B;
- (h) H. Influenza Type B (HIB); and
- (i) Such other types may be determined by the Secretary of Health

**WHEREAS**, in accordance with Article II Section 15 of Philippine Constitution, the State shall protect and promote the right to health of the people and instill health consciousness among them;

**WHEREAS**, Republic Act 7160 states that every Local Government Unit shall exercise the powers to support and promote health and safety in their respective territorial jurisdiction;

**WHEREAS**, Pasay City Government supports the immunization of child to protect them against more diseases and keep other children safe by eliminating or greatly decreasing dangerous diseases that used to spread from child to child;

**WHEREAS**, pursuant thereto, the Pasay City Local Health Board adopted Resolution No. 06-G, Series of 2024 approved on June 21, 2024 *“Adopting RA No. 10152 otherwise known as the Implementation of Basic Immunization Services for Infants and Children”*;

**WHEREAS**, on December 04, 2024, the Honorable City Mayor Imelda Calixto-Rubiano endorsed to the Sangguniang Panlungsod a copy of the above mentioned resolution for approval and adoption of the Sangguniang Panlungsod;
