WHEREAS, the Local Government Code in Section 102 provides that the local health board, consistent with the technical and administrative standards of the Department of Health, shall create committees which shall advise local health agencies on matters such as, but not limited to, personnel selection and promotion, bids and awards, grievances and complaints, personnel discipline, budget review, operations review and similar functions;

WHEREAS, the Universal Health Care Act integrates the local system into city-wide health system to ensure the effective and efficient delivery of population-based and individual-based health services;

WHEREAS, Resolution No. 6579, Series of 2023 supports the intent of the Local Government of Pasay to be a part of the integration site on the implementation of the Universal Health Care;

WHEREAS, in the commitment of the City of Pasay for the implementation of the Universal Health Care Act, it is necessary to organize and create a Pasay City Universal Health Care Technical Working Group ("PCUHC-TWG");

WHEREAS, pursuant thereto, the Pasay City Local Health Board adopted Resolution No. 06-H, Series of 2024 approved on June 21, 2024 "Creating the Universal Health Care Technical Working Group and Defining the Duties and Functions Thereof";

WHEREAS, on December 04, 2024, the Honorable City Mayor Imelda Calixto-Rubiano endorsed to the Sangguniang Panlungsod a copy of the above mentioned resolution for approval and adoption of the Sangguniang Panlungsod;
