**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR IMELDA CALIXTO-RUBIANO TO ENTER INTO AND SIGN, ON BEHALF OF THE CITY GOVERNMENT OF PASAY, THE DEEDS OF DONATION OF SMALL GREENHOUSES FREE INSTALLATION TO BE GIVEN TO THE HEREUNDER ENUMERATED COOPERATIVES IN PASAY CITY, SUBJECT TO ALL EXISTING LAWS, RULES, AND REGULATIONS**

**WHEREAS**, the Pasay Cooperative Development Office and Pasay Disaster Risk Reduction Management Office proposed a project entitled “Pasay Installation of Sustainable Pasay Portable Farm Cum Organic Vegetable Farm for Food Security, Hunger and Malnutrition Mitigation and Environmental Care Project” that aims to implement a socialized food production using aquaponics and hydroponics and other portable & vertical farming technology to help feed the household in the communities and/or cooperative members’ families;

**WHEREAS**, it also aims to create source of food for the people and households by encouraging or introducing planting in very small spaces, supporting and encouraging different establishments of self-watering gardens on front yards, rooftops, unused land space while increasing food source;

**WHEREAS**, this project is within the priority thrust of Honorable City Mayor Imelda Calixto-Rubiano in achieving better lives for Pasayenos under the Environment and Livelihood, by making available food and other products necessary to sustain and enhance human lives by promoting and realizing in-city urban vertical garden/urban farming tourism and encouraged the establishment of organic vegetable garden in all Barangays thru its program “*Engganyuhing Magtanim para sa Inang-kalikasan*”;

**WHEREAS**, this program is responsive to the Philippine commitment to achieve the Sustainable Development Goals (SDG), formerly known as Millenium Development Goals (MDG) and pursuant to R.A. 9003 also known as Solid Waste Management Act, R.A. 9275 also known as Philippine Clean Water Act, R.A. 10816 also known as Farm Tourism Development Act, City Ordinance No. 5631, Series of 2014, “Aasenso sa Green and Clean” Program: FEDROW (Family-based Ecological Diversion and Recycling of Waste), cum Portable Farm as a farming technology applicable in an urban setting;

**WHEREAS**, in a letter dated November 27, 2024, Ms. Rowena T. Buenaventura, City Cooperative Officer I of the Pasay Cooperative Development Office, forwarded a copy of the 2023 Proposed Project under the Disaster Risk Reduction Management Fund along with the lists of Cooperatives as **Donees** and requested for it to be endorsed to the Sangguniang Panlungsod for the issuance of a Resolution authorizing the City Mayor to sign the same;

**WHEREAS**, the City Government of Pasay intends to donate small greenhouses (3mx5m) along their implements to Marcela Marcelo Elementary School Consumers Cooperative, Malibay Drivers Transport and Multi-Purpose Cooperative, Fatima Pasay Credit Cooperative at Barangay 146, and Pasay City East High School Consumers Cooperative at Barangay 158, Pasay City;

**WHEREAS**, on December 04, 2024, the Honorable City Mayor Imelda Calixto-Rubiano officially endorsed to the members of the Sangguniang Panlungsod the copies of the said Deeds of Donation for the adoption of an appropriate legislation;

- (4) PASAY CITY EAST HIGH SCHOOL CONSUMERS COOPERATIVE AT BARANGAY 158, PASAY CITY.






