

**O R D I N A N C E**

AN ORDINANCE AMENDING ORDINANCE 271, S-1994 TO BE NOW ENTITLED "**ORDINANCE ESTABLISHING PAMANTASAN NG LUNGSOD NG PASAY, AS A PUBLIC EDUCATIONAL INSTITUTION.**"

**SPONSORED BY ALL MEMBERS OF THE SANGGUNIANG PANLUNGSOD**

**WHEREAS**, by virtue of the provisions of the Local Government Code of 1991, the functions of a municipal corporation is dual in nature in that one is governmental and the other is proprietary so that there will be no mistake as to governmental functions of the Pamantasan ng Lungsod ng Pasay thus amending ordinance is necessary to stress the fact that the Pamantasan ng Lungsod ng Pasay is run and operated by the City Government of Pasay in its governmental character to justify the charging of its operational and maintenance expenses to the Special Educational Fund of the mentioned municipal corporation.

It is hereby enacted by the Sangguniang Panlungsod in session duly assembled that:

**Section 1.** There is hereby established in the City of Pasay a university to be known as the "**Pamantasan ng Lungsod ng Pasay, a public educational institution, run and operated by the City Government of Pasay**", hereinafter referred to in this ordinance as **Pamantasan**.

**Section 2.** The Pamantasan shall provide four degree-granting courses in Commerce, Nursing and Midwifery and Education, and other such degree courses and vocational courses as may be deemed necessary by the Board of Regents to support the development and policy objectives of the city.

**Section 3. PURPOSES and OBJECTIVES:**

The Pamantasan shall:

- (a) provide at the most minimal costs post-secondary education to residents of the City, as well as to others, who may be admitted, as per the qualifications for admission set by the Board of Regents;
- (b) assist the city government in the training and development of its personnel for a more efficient administration;
- (c) inculcate in its students a sense of integrity and public service to prepare them to be dedicated leaders of the City.

**Section 4.** The governing body of the Pamantasan ng Lungsod ng Pasay, **a public educational institution run and operated by the City Government of Pasay**, shall be its Board of Regents: its membership to be comprised by the City Mayor as Chairman, the President of the University, the Division Superintendent of the City Schools, Chairman of

the Committee on Education of the Sangguniang Panlungsod, President of the University's Student Council and four (4) representatives from the private sector who are all recognized and respected in their fields of endeavor, which must necessarily be connected with the courses offered in the Pamantasan.

All members of the Board, except those who are serving in a concurrent capacity, shall be appointed by the Mayor, subject to the confirmation by the Sanggunian and further subject to the pertinent rules and regulations of the Department of Education and Sports and the Civil Service Commission.

Consultants may likewise be appointed by the Mayor, subject to the same requirements as above-mentioned, but they shall have no voting rights.

#### **Section 5. Powers and Functions of the Board of Regents:**

The Board of Regents of the Pamantasan ng Lungsod ng Pasay, a public educational institution run and operated by the City Government of Pasay, shall have the following powers, functions and authorities to wit:

(a) to appoint, upon the recommendation of the Mayor, and subject to DECS and Civil Service rules and regulations the following and confirmation by the Sanggunian:

1. University Secretary and other administrative officers;

2. Deans, heads or directors of colleges.

(b) to appoint faculty members with the rank of associate professor or higher, upon the recommendation of the Mayor and subject to DECS and Civil Service rules and regulations;

(c) to declare policies, adopt by-laws, issue rules and regulations, initiate plans and programs and to amend or repeal the same;

(d) to manage funds for the operation and management of the Pamantasan;

(e) to prepare its budget, subject to COA rules and regulations;

(f) to delegate certain authorities and responsibilities it may deem appropriate.

**Section 6.** The Members of the Board of Regents shall receive an allowance of Five Hundred (P500.00) Pesos for each and every meeting of the Board attended by them which shall be as often as necessary, as the Chairman of the Board may determine and call, but at least once a month.

#### **Section 7. Powers of the Presidents:**

The President shall be the Chief Executive of the University and shall have the following powers and responsibilities:

LUNGSOD NG PASAY, AS A PUBLIC EDUCATIONAL INSTITUTION RUN AND OPERATED BY THE CITY GOVERNMENT OF PASAY".

(a) to provide leadership to the Pamantasan ng Lungsod ng Pasay, a public educational institution run and operated by the City Government of Pasay and ensure the observance and implementation of the policies laid down by the Board;

(b) to appoint, upon recommendation of the Mayor, other faculty members and employees of the Pamantasan ng Lungsod ng Pasay, a public educational institution run and operated by the City Government of Pasay, not within the jurisdiction of the Board;

(c) to set up a machinery for disciplinary actions, provided that said actions shall be appealable to the Board;

(d) to submit to the Board the courses of study and academic programs, rules of discipline and conferment of degrees and diplomas as recommended by the University Council;

(e) to negotiate and obtain grants for specific projects, gifts and donations of property, subject to the confirmation of the Board and to administer the same for the benefit of the Pamantasan ng Lungsod ng Pasay, a public educational institution run and operated by the City Government of Pasay, according to the instructions of the donor, and in default thereof, as the Board may determine.

**Section 8.** The fiscal year of the Pamantasan ng Lungsod ng Pasay, a public educational institution run and operated by the City Government of Pasay, shall coincide with the school year as set up by the DECS and after each school year it shall render a report of its activities and operations to the Mayor and the Sanggunian.

**Section 9.** This ordinance shall take effect upon passage and approval by the Sangguniang Panlungsod, approval by the City Mayor and its publication, once, in a newspaper of general circulation in the City of Pasay.

**ENACTED in the City of Pasay, this 14<sup>th</sup> day of September, in the Year of Our Lord Nineteen Hundred and Ninety-Six.**
