R E S O L U T I O N

A RESOLUTION REQUESTING THE PASAY CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (PCENRO) TO FACILITATE THE STRICT IMPLEMENTATION OF ORDINANCE NO. 4647, S-2011, AS AMENDED BY ORDINANCE NO. 5981, S-2019, OTHERWISE KNOWN AS “AN ORDINANCE REGULATING THE USE OF NON-COMPOSTABLE PLASTIC CARRY OUT BAGS IN PASAY CITY AND PROMOTING THE USE OF RECYCLABLE PAPER CARRY OUT BAGS AND REUSABLE CARRY OUT BAGS, PRESCRIBING THE PENALTIES THEREOF” AND THEREBY TOTALLY BANNING CARRY OUT PLASTIC BAGS IN THE CITY OF PASAY.

WHEREAS, Ordinance No. 4647, S-2011, otherwise known as “an ordinance regulating the use of non-compostable plastic carry out bags in Pasay City and promoting the use of recyclable paper carry out bags and reusable carry out bags, prescribing penalties for violations thereof” was enacted on 12 September 2011;

WHEREAS, Ordinance No. 5981, S-2019 was enacted on 28 January 2019 to amend the abovementioned ordinance and thereby totally banning the use of plastic carry out plastic bags in the City of Pasay;

WHEREAS, Section 3 of the abovementioned ordinance prohibits stores to provide to any customer any kind of “plastic carry out bags”;

WHEREAS, there is a request from concerned constituent to implement in the City of Pasay the above mentioned ordinance as there are stores and/or establishments within the jurisdiction of Pasay City that provides “plastic carry out bags” to its customers;

WHEREAS, there is a need for strict enforcement of the abovementioned ordinance specifically those provided in Section 8 thereof.
