WHEREAS, City University of Pasay (CUP) Board of Regents adopted Resolution No. 08, Series of 2020 dated December 16, 2020 entitled "*Resolution Approving the Change of Program Nomenclature from Master in Public Governance to Master in Public Administration*";

WHEREAS, this is pursuant to the recognition of the University of the ever changing need of the City and the country for programs and/or courses to be offered and the fact that most, if not all state universities, local colleges, and universities are offering Business Administration in both undergraduate and master in lieu of Public Governance;

WHEREAS, the Commission on Higher Education (CHED) does not recognize the Master in Public Governance program of the university and recommends that it be changed to Master in Public Administration;

WHEREAS, Section 2.4, Article III of the Sangguniang Panlungsod Ordinance No. 4604, Series of 2011 states that the Board of Regents shall have the power to regulate the governance of the City University of Pasay consistent with the purpose of the University to approve a course of study curricular, rules of discipline, and the establishment of graduate and undergraduate programs, other technical and vocational courses drawn by the University Council to respond to the manpower needs of the community and to provide adequate support for them to ensure proper implementation;

WHEREAS, Dr. Romulo Navarra, Dean of the Graduate School, discussed in a presentation that the current program of Master in Public Governance of the university is similar to that of the Master in Public Administration offered by different local colleges and universities and in fact requires more number of units than those offered by other schools;

NOW THEREFORE, BE IT RESOLVED, AS IT HEREBY RESOLVED, by the Sangguniang Panlungsod in a session duly assembled, APPROVING AND ADOPTING THE BOARD OF REGENTS (BOR) RESOLUTION OF THE CITY UNIVERSITY OF PASAY (CUP) CHANGING THE PROGRAM NOMENCLATURE FROM MASTER IN PUBLIC GOVERNANCE TO MASTER IN PUBLIC ADMINISTRATION SUBJECT TO APPLICABLE LAWS, RULES AND REGULATIONS.




