WHEREAS, before His death, He served as the Presiding Judge of Court of Industrial Relation, a Retired Judge of the Regional Trial Court of Makati City and a Delegate of the Philippine Constitutional Convention of 1971 which was called to change the 1935 Constitution;

WHEREAS, Paredes also served in the City Government of Pasay as Councilor from 1955 to 1959, as Vice Mayor from 1959 to 1963 and, and as Acting Mayor in 1961;


