**WHEREAS**, Home Development Mutual Fund (Pag-IBIG Fund) shall extend an additional facility on availing the loan program of the Fund by implementing the Online Short-Term Loan (STL) Application through Virtual Pag-IBIG;

**WHEREAS**, the Pasay City Government supports Pag-IBIG Fund's program and agrees to certify and confirm the STL application of its employees and submits online to Pag-IBIG Fund;

**WHEREAS**, the Pag-IBIG Fund and the Pasay City Government through their Authorized Approving Officer agree to cooperate with and assists one another in the implementation of the Online STL application through Virtual Pag-IBIG;

**WHEREAS**, the mentioned Memorandum of Agreement has been reviewed by Atty. Severo C. Madrona, Jr, City Legal Officer, and found it to be consistent with the law as stated in a letter dated July 28, 2021 addressed to Atty. Maverick S. Sevilla, City Government Department Head II, Human Resource Management and Development Office, provided that express consent of the employee is indicated in the loan documents that he/she agree that the corresponding monthly amortization on the loan and the Membership Savings (MS) of the applicant will be through salary deduction, and the Pasay City Government will remit the same to Pag-IBIG Fund;

**WHEREAS**, in a letter addressed to Honorable Mayor Imelda Calixto-Rubiano dated August 5, 2021, Mr. Emelito B. Tecson, Acting City Treasurer, interposes no objection with the City Legal Officer's Opinion on the said Memorandum of Agreement;

**WHEREAS**, on July 30, 2021, Atty. Maverick S. Sevilla, City Government Department Head II, Human Resource Management and Development Office, requested Atty. Dennis Bernard N. Acorda, City Administrator, for endorsement of the MOA to the City Council for its approval and implementation;

**WHEREAS**, Honorable City Mayor Imelda Calixto-Rubiano, in an endorsement dated August 2, 2021, has endorsed to the Sangguniang Panlungsod through the Office of the City Secretariat, the above mentioned MOA and its attached documents requesting for the adoption of the corresponding resolution;




