RESOLUTION NO. 897, S-1997

A RESOLUTION URGING PASAY CITY HEALTH OFFICER DRA. ELVIRA M. LAGROSA TO PROSECUTE ALL PERSONS LIABLE UNDER SANITARY LAWS, ORDINANCES AND/OR REGULATIONS FOR THE HUMAN EXCRETA AND EFFLUENT EMANATING FROM THE APARTMENT AT THE CORNER OF TAFT AVENUE AND SEN. GIL PUYAT AVENUE, PASAY CITY.

WHEREAS, in the Pulong Tulungan held on January 24, 1997, and attended by Vice Mayor Wenceslao B. Trinidad, the Members of City Council and several departments heads of the Pasay City Government, Barangay Captain Leovina B. Acero of Barangay 47, Zone 6, again brought up her three-year old complaint regarding human excreta and effluent coming out from the drainage of an apartment located at the corner of Taft Avenue and Sen. Gil Puyat Avenue, Pasay City;

WHEREAS, on September 21, 1995, Pasay City Health Officer Dra. Elvira M. Lagrosa whose attention to the nuisance had been called, endorsed to the City Secretary the report on the matter made by her subordinate, Sanitation Inspector Rosendo A. Cabanayan, dated September 18, 1995, confirming the existence of the unsightly and foul-smelling "Nuisance to the passers-by as well as to the neighborhood," plus the accumulated waste water in one door of the apartment emitting very undesirable odor;

WHEREAS, as alleged in the report, no action on the nuisance could be taken because the name and address of the owner was not known to the occupants of the apartment;

WHEREAS, on April 10, 1996, it came to the knowledge thru the Sanitary Inspector that the Administrator of the apartment in question is Mr. Cresencio A. Anorico; with an Office address Life Theater, Inc., 4th floor, Saville Building., #8728 Paseo de Roxas, Makati City, Philippines; such a fact has been known by the Office of the City Health Officer but no effective action has to date been taken to abate the nuisance; and

WHEREAS, the City Health Officer is empowered to execute and enforce all sanitary laws, ordinance and regulations, according to Sec. 487 (4) (iii), (v) & (vi) of the Local Government Code of 1991;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL IN SESSION ASSEMBLED, that Pasay City Health Officer Dra. Elvira M. Lagrosa be, as she is hereby, urged to take immediate and necessary steps to cause the prosecution of all the persons who are liable for violations of sanitary laws, ordinances and/or regulation as a result of the nuisance consisting of human excreta and effluent emanating from the apartment of the corner of Taft Avenue and Sen. Gil Puyat Avenue, Pasay City.


