**A RESOLUTION APPROVING AND ADOPTING RESOLUTION NO. 22, SERIES OF 2024 OF BARANGAY 183, ZONE 20, PASAY CITY, ALLOWING THE BUREAU OF FIRE PROTECTION, PASAY CITY, TO TEMPORARY HOLD ITS OFFICE AS THEIR SUB-STATION IN BARANGAY HALL OF BARANGAY 183, ZONE 20, VILLAMOR, PASAY CITY, SUBJECT TO COMPLIANCE WITH ALL APPLICABLE LAWS, RULES & REGULATIONS ON THE MATTER**

**WHEREAS**, under Section 16 (General Welfare) of the Local Government states that:

*“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, xxx, promote health and safety, xxx.”*

**WHEREAS**, under Section 17 (Basic Services and Facilities) on the same code states that:

*“(a) xxx Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities enumerated herein. xxx”*

**WHEREAS**, Barangay 183 being the biggest Barangay in Pasay City in terms of area and population with 54 hectares of residential area which consist of estimated 8,000 households living in houses made of light and concrete materials which are built very close to each other, making the community vulnerable to fire hazard;

**WHEREAS**, with limited resources and barangay fire marshal available, it is not enough to cater the need especially when major fire disaster arises, hence, the Barangay Council made a coordination to partner with the Bureau of Fire Protection, Pasay City to have a sub-station in the vicinity of Barangay 183;

**WHEREAS**, due to lack of area, it was agreed that the Bureau of Fire Protection, Pasay City will temporarily use a vacant room in the Barangay Hall of Barangay 183;

**NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod, in session duly assembled, **APPROVING AND ADOPTING RESOLUTION NO. 22, SERIES OF 2024 OF BARANGAY 183, ZONE 20, PASAY CITY, ALLOWING THE BUREAU OF FIRE PROTECTION, PASAY CITY, TO TEMPORARY HOLD ITS OFFICE AS THEIR SUB-**

## MEMORANDUM OF AGREEMENT

### KNOW ALL MEN BY THIS PRESENTES:

This Agreement is made and entered into this 16th day of April 2024 in the City of Pasay, Metro Manila, Philippines by and between:

**BARANGAY 183, ZONE 20, PASAY CITY**, with an office address at Mata street, Barangay 183, Zone 20, Villamor, Pasay City represented by **PUNONG BARANGAY ALVIN A. ZUÑIGA**, hereinafter referred to as the "**Barangay**,"

and

**BUREAU OF FIRE PROTECTION (BFP) DEPARTMENT PASAY CITY**, with an office address at A. Arnaiz Ave., Pasay City represented by **CITY FIRE MARSHALL SUPT. MARIANO S. TAGUIAM**, hereinafter referred to as the "**BFP**."

WHEREAS, the Barangay is vested with the responsibility to ensure the safety and welfare of its constituents, including fire prevention and suppression measures within its jurisdiction;

WHEREAS, the Bureau of Fire Protection, by virtue of both RA 6975 or the DILG Act of 1990 and the RA 9514 of the Fire Code of the Philippines of 2008 has the mandate to prevent and suppress destructive fires at all cost with the active participation of the community;

WHEREAS, both parties recognize the importance of collaboration and coordination in enhancing fire safety and prevention efforts within the Barangay;

NOW, THEREFORE, in consideration of the foregoing premises and the mutual covenants herein contained, the parties hereto agree as follows:

### SECTION 1. PURPOSE:

The purpose of this MOA is to establish a framework for cooperation and coordination between the Barangay and the BFP in the implementation of fire safety and prevention programs within the Barangay's jurisdiction.

### SECTION 2. SCOPE OF COOPERATION:

a. This MOA shall cover the implementation of BFP fire safety and prevention Programs within Barangay 183, Pasay City. In Furtherance thereto, the BFP may be called upon and ask for the assistance and support of Barangay as may be necessary

### SECTION 3. RESPONSIBILITIES OF THE PARTIES:

- a. The Barangay shall:
  - i. Provide assistance and logistical support to the BFP during fire incidents, emergency operations and other disasters within its jurisdiction.
  - ii. Provide a room for the BFP sub-station in the Barangay hall.
  - iii. Coordinate with the BFP in the conduct of fire safety inspections and drills.

- iv. Allocate funds, resources, and manpower for the implementation of fire safety programs.
- b. The BFP shall:
  - i. Provide technical assistance and training to Barangay officials, personnel and residents on fire prevention, suppression and other disasters.
  - ii. Conduct regular inspections and assessments of fire risks within the Barangay.
  - iii. Respond promptly to fire incidents and provide necessary support and expertise to mitigate damages.
  - iv. Provide service for establishments who will apply for fire clearance upon compliance of the requirements.
  - v. Provide all supplies, tools, equipment needed in the sub-station.
  - vi. Provide 1 stationed fire truck that will be operated by the BFP.

 **SECTION 4. RESOURCE SHARING:**

Both parties shall endeavor to share relevant resources, including but not limited to equipment, personnel, and expertise, to effectively carry out the activities specified under this MOA.

 **SECTION 5. CONFIDENTIALITY:**

Any information exchanged between the parties in the course of implementing this MOA shall be treated as confidential and shall not be disclosed to third parties without prior written consent.

**SECTION 6. EFFECTIVITY AND TERMINATION:**

This Agreement shall commence upon the signing of this document and shall remain effective unless revoke by the parties for just and valid reasons.


**SECTION 7. AMENDMENTS:**




