A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR IMELDA CALIXTO-RUBIANO, FOR AND ON BEHALF OF THE CITY GOVERNMENT OF PASAY, TO ACCEPT THE BIOWASTE CONVERTER TECHNOLOGY (RAPID COMPOSTER) AS A DONATION FROM THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY (MMDA) SUBJECT TO COMPLIANCE WITH ALL APPLICABLE LAWS, RULES & REGULATIONS ON THE MATTER

WHEREAS, Section 22 paragraph c of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 which states that no contract may be entered into by the Local Chief Executive for and on behalf of the Local Government Unit (LGU) without prior authorization by Sangguniang Panlungsod.

WHEREAS, the Metro Manila Development Authority (MMDA) is implementing the Metro Manila Flood Management Project (MMFMP) to improve flood management in selected areas in Metro Manila including Pasay City.

WHEREAS, pursuant thereto, Solid Waste Management (SWM) Equipment will be donated by the MMDA to selected Local Government Units (LGUs) in Metro Manila for the following purposes: (1) to raise awareness and promote behavioral change towards proper solid waste management; (2) to support the implementation of improved programs and activities that prevent solid waste in waterways from reaching the pumping stations; and (3) to encourage the community to actively participate in all solid waste management activities.

WHEREAS, on July 08, 2024, the Honorable Imelda Calixto-Rubiano, City Mayor, officially endorsed to the Honorable Members of the Sangguniang Panlungsod thru the Office of the City Secretary the request for the issuance of a Sanggunian Resolution granting her prior authorization together with the draft of the Deed of Donation and Acceptance.
