A RESOLUTION DECLARING A STATE OF CALAMITY IN THE CITY OF PASAY DUE TO EFFECTS BROUGHT BY SOUTHWEST MONSOON ENHANCED BY SUPER TYPHOON CARINA AS RECOMMENDED BY THE PASAY CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL SUBJECT TO APPLICABLE LAWS, RULES AND REGULATIONS

WHEREAS, Section 4 of Article II of the Constitution declares that the prime duty of the Government is to serve and protect the people;

WHEREAS, Section 9 of Article II of the Constitution states that the State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all;

WHEREAS, Republic Act 10121, An Act Strengthening the Philippine Disaster Risk Reduction and Management System, Providing for the National Disaster Risk Reduction and Management Framework and Institutionalizing the National Disaster Risk Reduction and Management Plan, Appropriating Funds Therefor and For Other Purposes, also known as the “Philippine Disaster Risk Reduction and Management Act of 2010, was enacted by the Senate and House of Representatives of the Philippines in Congress on February 1, 2010 and was approved by Gloria Macapagal Arroyo, President of the Philippines on May 27, 2010;

WHEREAS, Section 21 of the Republic Act 10121 states that the “Local Calamity Fund shall henceforth be known as the Local Disaster Risk Reduction and Management Fund (LDRRMF)” which is “not less than five percent (5%) of the estimated revenue from regular sources shall be set aside as the LDRRMF to support disaster risk management activities” and that “30% shall be allocated as Quick Response Fund (QRF) or stand-by fund for relief and recovery programs” while the “unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the LDRRMCs within the next five years”;

WHEREAS, Item 4.0 of the Joint Memorandum Circular No. 2013-1 dated March 25, 2013, issued by the NDRRMC, DBM, and DILG, provides that the LDRRMF shall cover the thirty percent (30%) lump-sum allocation for Quick Response Fund (QRF) and the seventy (70%) allocation for disaster prevention and mitigation, preparedness, response and rehabilitation and recovery, while Item 5 of the Joint Memorandum Circular No. 2013-1, enumerated projects and activities in the utilization of the LDRRMF;

WHEREAS, the Pasay City Disaster Risk Reduction and Management Council has approved the Local Disaster Risk Reduction and Management Fund Investment Program 2024 with the amount of Three Hundred Seventy Two Million Seven Hundred Ten Thousand Pesos (P372,710,000.00), 70% of which is allocated for the DRRM-related PPAs of the City amounting to Two Hundred Sixty Million Eight Hundred Ninety Seven Thousand Pesos (P260,897,000.00), while 30% amounting to One Hundred Eleven Million Eight Hundred Thirteen Thousand Pesos (P111,813,000.00) will be set aside as the Quick Response Fund to be used in relief and recovery programs of the City;

WHEREAS, the National Disaster Risk Reduction and Management Council has issued Memorandum Order No. 60 of 2019 setting the “Revised Guidelines for the Declaration of a State of Calamity, wherein it defined State of Calamity as a “condition involving mass casualty and/or major

damages to the environment, property, infrastructures, disruption of means of livelihoods and businesses, and normal way of life of people in the affected areas as a result of the occurrence of natural or human-induced hazard”;

WHEREAS, Section 3 of the NDRRMC Memo No. 60 of 2019 provides that a City may declare a State of Calamity when (1) at least fifteen (15%) of the forecasted affected population based on science-based projection are in need of emergency assistance, (2) at least thirty percent (30%) of the means of livelihood on agricultural, business and industrial sectors are affected, and (3) damage to critical and lifeline infrastructure/facilities;

WHEREAS, Southwest Monsoon (Habagat) enhanced by Super Typhoon Carina has brought significant impacts in the City, flooding incidents in different barangays have caused displacement of residents affecting their daily lives and livelihood, leading to efforts in search and rescue operations and relief distribution operations by the City Government of Pasay;

WHEREAS, the Metro Manila Council has placed Metro Manila under the State of Calamity;

WHEREAS, pursuant thereto, the Pasay City Risk Reduction and Management Council Meeting duly assembled and chaired by the Hon. Imelda Calixto – Rubiano, City Mayor, upon assessment and coordination of the situation on the effects of the stated incident with different responding offices/agencies under the City Government of Pasay, has agreed to recommend to the Sangguniang Panlungsod the declaration of state of calamity in the City of Pasay, thereby, accessing the Quick Response Fund of the Local Disaster Risk Reduction and Management Fund, to ensure that necessary goods and services are delivered to the affected population;


WHEREAS, pursuant thereto, the Pasay City Risk Reduction and Management Council issued Resolution No. 04, Series of 2024 entitled “A Resolution Recommending To The Sangguniang Panlungsod The Declaration Of State Of Calamity In The City Of Pasay Due To Effects Brought By Southwest Monsoon Enhanced By Super Typhoon Carina”;


WHEREAS, in an endorsement from Honorable Imelda Calixto-Rubiano, City Mayor, addressed to the Honorable Members of the Sangguniang Panlungsod, thru the Office of the City Secretary, the former requested for the adoption of a resolution declaring the same;


NOW THEREFORE BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod, in session duly assembled, **DECLARING A STATE OF CALAMITY IN THE CITY OF PASAY DUE TO EFFECTS BROUGHT BY SOUTHWEST MONSOON ENHANCED BY SUPER TYPHOON CARINA AS RECOMMENDED BY THE PASAY CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL SUBJECT TO APPLICABLE LAWS, RULES AND REGULATIONS.**


