WHEREAS, Article XIV, Section 19 of the 1987 Constitution provides that, “The state shall promote physical education and encourage sports programs, league competitions and amateur sports to foster self-discipline, teamwork and excellence for the development of healthy and alert citizenry”;

WHEREAS, Republic Act No. 6847 created the Philippine Sports Commission (PSC) to serve as the sole policy-making and coordinating body of all amateur sports development programs and institutions in the Philippines;

WHEREAS, the City of Pasay has requested for financial support for the funding of sports development programs for its schools and communities;

WHEREAS, the PSC, in line with its mandate under Republic Act No. 6847 to spearhead the sports promotion and development programs of the country, is committed to help ensure and favorably considered and approved the requested financial assistance for the funding of sports development programs for their schools and communities;

WHEREAS, the PSC has approved the grant of financial assistance to the City Government for the funding of sports development programs for its schools and communities amounting to Four Million Pesos (Php4,000,000.00) and full authority to its Chairman to enter into this Agreement as provided under Board Resolution No. 1334-2023 dated 19 October 2023;






