NOW THEREFORE BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod, in session duly assembled, CONVEYING SUPPORT TO HOUSE BILL NO. 10314 ENTITLED "AN ACT RATIONALIZING THE BENEFITS AND PRIVILEGES OF SENIOR CITIZENS AND PERSONS WITH DISABILITIES".
