WHEREAS, the passage of House Bill No. 10314 will significantly impact the lives of senior citizens and persons with disabilities, providing them with enhanced support and opportunities to live with dignity and independence;

NOW THEREFORE BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod, in session duly assembled, **CONVEYING SUPPORT TO HOUSE BILL NO. 10314 ENTITLED “AN ACT RATIONALIZING THE BENEFITS AND PRIVILEGES OF SENIOR CITIZENS AND PERSONS WITH DISABILITIES”**.
