WHEREAS, Resolution No. 4624, Series of 2019 entitled “A Resolution Recognizing the List of Cultural Property Inventory which was submitted to the National Commission for Culture and the Arts (NCCA) on August 13, 2018 provided all applicable laws, rules and regulations are complied” was approved and adopted by the Sangguniang Panlungsod on April 30, 2019;

WHEREAS, thereafter, on 14 June 2023 the Sanggunian approved and adopted Resolution No. 6576, Series of 2023, adding Twenty-One other Significant Institutions, Tangible Movable and Immovable Heritage, and Personalities as indicated in the Updated Local Cultural Inventory of the Pasay Historical and Heritage Commission;

WHEREAS, a Sanggunian Resolution is a requirement of the Philippine Registry of Cultural Properties of the National Commission of Culture and the Arts (PRECUP-NCCA) in order to secure a Certificate of Compliance in accordance to DILG-NCCA Joint Memorandum 2021-001 and Article V of the Republic Act No. 10066 of the National Cultural and Heritage Act of 2009;

WHEREAS, in a letter dated 19 February 2025, addressed to the Honorable City Mayor Imelda Calixto-Rubiano, Ms. Teresita C. Robles, Chairperson, Pasay Culture and Arts Council, requested for the passage of a Resolution Updating the City’s Cultural Inventory, thereby adding six (6) Significant Tangible Immovable Heritage which were installed from 2020 to 2024 in order to protect and preserve our cultural heritage;

WHEREAS, on February 21, 2025, Honorable City Mayor Imelda Calixto-Rubiano endorsed to the Members of the Sangguniang Panlungsod thru the City Secretary, the letter from Ms. Teresita C. Robles with the request for the passage of a Resolution for the purpose;




